- Faculty Senate Agenda for 4/30/24 (special meeting) approved.

Other Items

- Provost Q&A
 - CAS staffing issues and implications for PhDs, teaching loads, and degree programs. Requested Provost to give a statement to the Faculty Senate.
 - Provost stated CAS issues were not Senate issues.
 - Dean has over hired and increased faculty across CAS. The budget is overextended thus searches needed to cease.
 - Expenditures and revenue for CAS need to match. Provost is working with the Dean to navigate this issue.
 - Does Provost approve Dean faculty searches? No
 - The Dean of CAS gave a presentation to their Policy Committee and the Provost feels this is the right approach.
 - Disciplinary excellence will be jeopardized. Provost pointed out that the number of tenure track faculty
 has increased. UB has done historic hiring and will take steps to better align resources. It will be better
 to not bring faculty here that, fiscally, we are currently unable to support.
 - UB has invested significantly in CAS over the last few years and hired some diverse and senior faculty.
 We've expanded departments and created new programs.
 - o A final request for better/more communication with the CAS faculty was made.
 - State budget was just approved any feedback on SUNY/UB budget?
 - No, could take 1-2 months
 - We are getting \$275million for Empire AI (hardware and building)

- Provost asked to comment on Spectrum report that student government candidates are not allowed to say what they'd advocate for if elected?
 - First the Provost has heard of this.
- The chair was asked for a list University-wide, administrative committees that have faculty representation. The chair had asked the Provost for such a list and he is working on it.
- Tenure, Promotions, and Privileges committee chair reported on Faculty/Staff Handbook amendments. VP for Faculty affairs met with committee and gave extensive revisions. Committee believes most suggestions are acceptable. However, some were not and they are still working with Dr. Granfield on a way to move forward.
 - Will this go back to the Faculty Senate? Parliamentarian said due to it being a substantial rewriting from what the Faculty Senate voted to approve it would have to come back to the EC in the revised version and be approved for a reading to the Faculty Senate. The Bylaws do give the Chair the right to waive the 2 reading rule.
- SUNY Senator Stapleton encouraged members to let faculty know SUNY Senate needs committee members. https://www.sunyufs.us/committee-reports.html. The standing committees are 1) Communications; 2) Equity, Inclusion, and Diversity; 3) Ethics; 4) Governance; 5) Graduate and Research; 6) Operations; 7) Programs and Awards; 8) Student Life; and 9) Undergraduate Programs and Policies.
